GRANT OF EXTENSION OF TIME TO COMPLY WITH RULE 707(1) OF THE LISTING MANUAL-SECTION B: RULES OF CATALIST OF THE SINGAPORE EXCHANGE SECURITIES TRADING LIMITED BY 31 MAY 2023 IN RESPECT TO HOLDING COMPANY'S FY2022 ANNUAL GENERAL MEETING ("AGM")

The Board of Directors ("**Board**" or "**Directors**") of YKGI Limited (the "**Company**", and together with its subsidiaries, the "**Group**") refers to the Company's announcement dated 3 April 2023 ("**3 April Announcement**") in relation to its application to the Singapore Exchange Securities Trading Limited ("**SGX-ST**") for an extension of time to comply with the requirements of Rule 707(1) of the Listing Manual Section B: Rules of Catalist ("**Catalist Rules**") of the SGX-ST. Capitalised terms in this announcement (unless otherwise defined or the context otherwise requires) have the same meaning as ascribed to them in the 3 April Announcement.

1. GRANT OF EXTENSION OF TIME

The Board wishes to announce that the Company has on 19 April 2023, received a letter from the SGX-ST informing the Company that it has no objection to the Company's application for extension of time to 31 May 2023 (the "**Waiver**") with regard to compliance with Rule 707(1) of the Catalist Rules, subject to the following (each, a "**Condition**", and collectively, the "**Conditions**"):

- (a) the Company announcing the Waiver granted, the reasons for seeking the Waiver, the conditions as required under Catalist Rule 106 and if the Waiver's conditions have been satisfied. If the Waiver's conditions have not been met on the date of the announcement, the Company must make an update announcement when the Conditions have all been met;
- (b) the Board of Directors' confirmation that the Waiver will not be in contravention of any laws and regulations governing the Company and its constitution; and
- (c) the Company convening its FY2022 AGM by 31 May 2023.

The Waiver will not be effective if any of the Conditions have not been fulfilled.

Following the 3 April Announcement, which sets out, inter alia, the Company's reasons for seeking the Waiver, and the disclosures made in this announcement, the Company has complied with the Condition set out in paragraph 1(a) of this announcement.

2. CONFIRMATION BY THE COMPANY

To the best of the Board's knowledge and belief, pending the outcome of the ACRA Application, the Waiver will not be in contravention of any laws and regulations governing the Company or its Constitution as a result of the Waiver.

3. ACRA APPLICATION

The Company has on 6 April 2023 applied to ACRA for an extension of time to hold its FY2022 AGM pursuant to Section 175(1)(a) of the Companies Act and to file its FY2022 annual return with ACRA pursuant to Section 197(1)(a) of the Companies Act. The Company will make a further announcement to update its shareholders on the outcome of the ACRA Application in due course.
