Ms. Liew Oi Peng ("Ms. Liew") is the spouse of Mr. Neo Kah Kiat ("Mr. Neo"). Ms. Liew is accordingly deemed to have an interest in the shares held by Mr. Neo.

The change in both the deemed and direct interests took place during the offer period of the voluntary conditional cash offer (the "Offer") made by United Overseas Bank Limited, for and on behalf of Forestt Investment Pte. Ltd. (the "Offeror"), to acquire all the issued and paid-up ordinary shares (the "Shares") in the capital of Neo Group Limited at S\$0.60 in cash for each Share (the "Offer Price"), during the period of the Offer from 13 April 2021 to 25 May 2021 (the "Offer Period").

Ms. Liew and Mr. Neo had validly tendered their Shares in acceptance of the Offer, in accordance with their undertakings as disclosed in the offer document dated 13 April 2021 (the "Offer Document"). As disclosed in the Offer Document, Ms. Liew and Mr. Neo had agreed that the consideration payable by the Offeror in respect of her Shares shall be satisfied in full by setting off such consideration against the aggregate subscription price payable by Ms. Liew and Mr. Neo for their subscription of new ordinary shares in the capital of the Offeror in the shareholding proportion of 90% and 10% for Mr. Neo and Ms. Liew, respectively.

During the Offer Period, the Offeror received valid acceptances in respect of an aggregate of 145,831,455 Shares pursuant to the Offer. Ms. Liew is deemed to have an interest in the 145,831,455 Shares owned by the Offeror as Ms. Liew is the spouse of Mr. Neo and Mr. Neo is entitled to exercise or control the exercise of all the votes attached to the voting shares of the Offeror. The Shares owned by the Offeror are held in the name of its nominee, United Overseas Bank Nominee (Private) Limited.
