On March 24, 2021, Exa Limited entered into a Sale and Purchase Agreement to dispose of 49,553,497 Grand Banks Yachts Limited shares representing their entire shareholding in Grand Banks Yachts Limited to Tan Sri Lim Kok Thay. Completion of the sale and purchase took place on March 25, 2021.

The percentage of interest held by Tan Sri Lim Kok Thay is computed based on the total issued shares of 184,634,649 of Grand Banks Yachts Limited as at March 24, 2021.
