This form is for a Director/Chief Executive Officer ("CEO") to give notice of his interests in the securities of the Listed Issuer under section 133, 137N or 137Y of the Securities and Futures Act (Cap. 289) (the "SFA"). Please note that the requirement to disclose interests in participatory interests applies **only** to a director and where the Listed Issuer is a Singapore-incorporated company.

The Listed Issuer will attach both forms to the prescribed SGXNet announcement template for dissemination as required under section 137G(1), 137R(1) or 137ZC(1) of the SFA, as the case may be. While Form C will be attached to the announcement template, it will not be disseminated to the public and is made available only to the Monetary Authority of Singapore (the "Authority").

There must be no netting-off of two or more notifiable transactions even if they occur within the same day.

Omali Corporation Sdn Bhd ("Omali") holds 121,562,760 ordinary shares in the Company. Lion Corporation Berhad ("LCB") is the ultimate holding company of Omali. Lion Diversified Holdings Berhad ("LDHB"), together with its subsidiaries, hold more than 20% of the voting rights in LCB and is thus deemed interested in the 121,562,760 ordinary shares in the Company held by Omali

AMB Venture Sdn Bhd ("AMBV") holds 148,750,644 ordinary shares in the Company. Lion Industries Corporation Berhad ("LICB") is the ultimate holding company of AMBV and is hence deemed interested in the 148,750,644 ordinary shares in the Company held by AMBV.

Andar Investment Pte Ltd ("Andar") holds 8,853,876 ordinary shares in the Company. Tan Sri Cheng Heng Jem ("TSWC") ceased to have an interest in Andar and is therefore no longer deemed interested in the 8,853,876 ordinary shares in the Company held by Andar.

TSWC remains deemed interested in the 121,562,760 ordinary shares in the Company held by Omali by virtue of his interest in LDHB, and the 148,750,644 ordinary shares in the Company held by AMBV by virtue of his interest in LICB.

Accordingly, TSWC's deemed interest in the share capital of the Company decreased from 68.84% to 66.66%.
