First Sponsor Management Limited holds a 67.5% interest in First Sponsor Capital Limited, which in turn holds 260,694,791 Shares directly and (ii) 50% interest in SG Investments Pte. Ltd., which holds 44% interest in Tai Tak Estates Sendirian Berhad, which holds 100% interest in Tai Tak Industries Pte Ltd, which in turn holds a 100% interest in Tai Tak Asia Properties Limited. Tai Tak Asia Properties Limited holds a 32.5% interest in First Sponsor Capital Limited, which in turn holds 260,694,791 Shares directly. Tai Tak Asia Properties Limited also holds 100% interest in Chengdu Tianfu Properties Ltd, which in turn holds 4,570,200 Shares directly.
