On 14 May 2019, Oversea-Chinese Banking Corporation Limited announced, for and on behalf of M-Universe Investments Pte. Ltd. (the "Offeror"), a voluntary conditional cash offer (the "Offer") for all of the issued ordinary shares (the "Shares") in the capital of Memtech International Ltd. other than those already owned, controlled or agreed to be acquired by the Offeror, its related corporations or their respective nominees.

The Offer was declared unconditional in all respects on 28 June 2019 (the "Offer Unconditional Date"), and the settlement of consideration for the Shares tendered in acceptance of the Offer on or before the Offer Unconditional Date was made on 9 July 2019 (the "Settlement").

Immediately prior to the Settlement, Gu Cheng Hua ("GCH") had a direct interest in 1,445,800 Shares. GCH tendered his Shares in acceptance of the Offer before the Offer Unconditional Date. Accordingly, immediately following the Settlement, GCH ceased to have any interest in the Shares.
