YHT Global Pte. Ltd. ("YHTG") acquired 2,813,900 ordinary shares in the capital of Hi-P International Limited ("Shares") on 5 January 2021 (the "YHTG Purchase").

Mr Yao Hsiao Tung ("Mr Yao") is the 100% shareholder of YHTG. Pursuant to Section 4 of the Securities and Futures Act (Chapter 289 of Singapore), he is deemed to have an interest in the 2,813,900 Shares acquired by YHTG pursuant to the YHTG Purchase.

Immediately before the YHTG Purchase, Mr Yao was deemed to have an interest in 42,575,482 Shares as he (a) holds options in Hi-P International Limited which allow him to subscribe for an aggregate of 4,360,382 Shares; and (b) was deemed to have an interest in 38,215,100 Shares held by YHTG (collectively, the "Pre-Transaction Interest"). Immediately after the YHTG Purchase, in addition to the Pre-Transaction Interest, Mr Yao is also deemed to have an interest in the 2,813,900 Shares acquired by YHTG pursuant to the YHTG Purchase.
