On 14 May 2021, TCC Assets Limited ("TCCA"), who holds Shares in FPL, transferred 70,000,000 Shares to TCC Group Investments Limited ("TCCGI") (the "Share Transfer"). Following the Share Transfer, TCCGI holds 70,000,000 Shares in FPL.

TCCGI (which is equally held by Atinant Bijanada, Thapana Sirivadhanabhakdi, Wallapa Traisorat, Thapanee Techajareonvikul and Panote Sirivadhanabhadi) holds the 70,000,000 Shares in FPL through a nominee account. Accordingly, TCCGI's interest in FPL is a deemed interest.

Panote Sirivadhanabhakdi, through his 20.0% shareholding in TCCGI, is deemed to be interested in all the Shares in FPL in which TCCGI is deemed interested by virtue of Section 4 of the Securities and Futures Act (Chapter 289 of Singapore).
