As a result of the 1 August Issuance, the REIT Manager has a direct interest in 63,901,107 Stapled Securities (the "RM Stapled Securities").

The REIT Manager is a wholly-owned subsidiary of OUE Limited ("OUE"). Accordingly, OUE has a deemed interest in the RM Stapled Securities and a direct interest in 585,775,399 Stapled Securities, amounting to a total interest in 649,676,506 Stapled Securities.
