Energian Pte. Ltd. (the "Offeror") received valid acceptances in respect of an aggregate of 406,288,481 issued and paid-up ordinary shares ("Shares") in the capital of CH Offshore Ltd. (the "Company") under the voluntary conditional cash offer (the "Offer") made by CIMB Bank Berhad, Singapore Branch for and on behalf of the Offeror to acquire all the Shares other than those already owned, controlled or agreed to be acquired by the Offeror at S\$0.550 for each Share, during the period of the Offer from 11 December 2014 to 27 February 2015 (the "Offer Period"). The Offer was declared unconditional in all respects on 11 February 2015. The Offeror also acquired an aggregate of 117,800 Shares at S\$0.495 for each Share by way of open-market purchases during the Offer Period.

Of the 406,288,481 Shares which were tendered in acceptance of the Offer, the Offeror had on 2 March 2015 disclosed its deemed interest in 93,584,975 Shares which at that date were pending settlement of the consideration due. Further to the notification by the Offeror on 2 March 2015, the consideration due for the remaining 93,584,975 Shares has since been settled and such Shares have been transferred to the Offeror on 5 March 2015. As such, the Offeror now has a direct interest in the remaining 93,584,975 Shares.

The Offeror is a direct wholly-owned subsidiary of Falcon Energy Group Limited ("FEG"). Mr Tan Pong Tyea has a controlling interest in FEG. Accordingly, Mr Tan Pong Tyea is deemed to have an interest in the Shares in which the Offeror has an interest.

There is no change in Mr Tan Pong Tyea's interest in the Shares and this notification is provided for information only.
