Due to an invocation of pledge on the shares of Fortis Healthcare Limited ("FHL") held by Fortis Healthcare Holdings Private Limited ("FHHPL"), the shareholding of FHHPL in FHL has been reduced from 34.33% to 8.75%. In aggregate, the shareholding of FHHPL, Malvinder Mohan Singh, Shivinder Mohan Singh, RHC Holding Private Limited and Malav Holdings Pvt. Ltd. has been reduced from 34.42% to 8.84%. Accordingly, by virtue of Section 4 of the SFA, each of FHHPL, RHC Holding Private Limited, Malav Holdings Pvt. Ltd., Shivi Holdings Pvt. Ltd., Malvinder Mohan Singh, Japna Malvinder Singh, Shivinder Mohan Singh and Aditi Shivinder Singh are no longer deemed interested in the Units in RHT Health Trust ("RHT") held by FHL and its subsidiaries (including the units in RHT held by RHT Health Trust Manager Pte. Ltd.). For the avoidance of doubt, there is no change in the interest of FHL and its subsidiaries in the Units in RHT.

Prior to the invocation of pledge of shares in FHL, FHHPL held approximately 34.33% of the issued and paid-up equity share capital of FHL. FHHPL is an investment holding company incorporated in India which is wholly-owned by RHC Holding Private Limited, an investment holding company incorporated in India. The issued shares of RHC Holding Private Limited are held in equal proportions by Malav Holdings Pvt. Ltd. and Shivi Holdings Pvt. Ltd., both of which are investment holding companies incorporated in India. Malvinder Mohan Singh and Japna Malvinder Singh hold 99.01% of Malav Holdings Pvt. Ltd. and Shivinder Mohan Singh and Aditi Shivinder Singh hold 99.02% of Shivi Holdings P Ltd. By virtue of Section 4 of the SFA, each of the FHHPL, RHC Holding Private Limited, Malav Holdings Pvt. Ltd., Shivi Holdings Pvt. Ltd., Malvinder Mohan Singh, Japna Malvinder Singh, Shivinder Mohan Singh and Aditi Shivinder Singh were previously deemed to be interested in the Units held by FHL and its subsidiaries in RHT.
