Kang Ru Investments Limited ("Kang Ru") holds 640,000,000 shares in the Company ("Shares"). Da Yuan Developments Limited ("Da Yuan") is the sole shareholder of Kang Ru. Vistra Trust (Singapore) Pte. Limited is the sole shareholder of Da Yuan and is the trustee of the Guo Yue Family Trust which is a discretionary trust. The Shares held by Kang Ru are assets of the Guo Yue Family Trust and the beneficiaries are Guo Jingyu and G.Y Media & Entertainment Limited, of which Guo Jingyu is the sole shareholder and director. Guo Jingyu is also the investment manager of the Guo Yue Family Trust.

Accordingly, pursuant to Section 4 of the Securities and Futures Act, Guo Jingyu is deemed to have an interest in all 640,000,000 Shares in the Company held by Kang Ru.
