Pursuant to a unit lending agreement dated 2 November 2017 between Keppel Capital Investment Holdings Pte. Ltd., KBS SOR Properties LLC and Merrill Lynch (Singapore) Pte. Ltd. (the stabilising manager for the Offering), Merrill Lynch (Singapore) Pte. Ltd. has borrowed 15,714,100 units ("Loaned Units") from each of Keppel Capital Investment Holdings Pte. Ltd. and KBS SOR Properties LLC. As a result, KBS SOR Properties LLC had a deemed interest in the Loaned Units.

Merrill Lynch (Singapore) Pte. Ltd. had, on 8 December 2017, exercised the over-allotment option granted by Keppel Capital Investment Holdings Pte. Ltd. and KBS SOR Properties LLC to purchase the Loaned Units in full. In conjunction with such exercise and as part of the same transaction, Merrill Lynch (Singapore) Pte. Ltd.'s obligation to re-deliver the Loaned Securities to Keppel Capital Investment Holdings Pte. Ltd. and KBS SOR Properties LLC was deemed to have been discharged on 15 December 2017 upon the payment of the Offering Price (as defined in the prospectus of Keppel-KBS US REIT) multiplied by the number of Loaned Units.
