On 13 July 2018, Northern entered into a share subscription agreement ("SSA") with Fortis Healthcare Limited ("Fortis"), pursuant to which Northern agreed to subscribe for 235,294,117 shares in Fortis. The Board of Directors of Fortis approved the allotment of shares under the SSA on 13 November 2018, resulting in Northern having a direct interest in 235,294,117 shares in Fortis, representing approximately 31.1% of the post-allotment total paid-up equity shares of Fortis.

Fortis, through its wholly-owned subsidiaries, Fortis Healthcare International Limited and RHT TM, has a deemed interest in a total of 225,747,944 units in RHT ("Units"), representing 27.82% of the Units in issue.

Accordingly, Northern is, under the Securities and Futures Act, Chapter 289 of Singapore (the "SFA"), deemed to be interested in the 225,747,944 Units in which Fortis is deemed to be interested in.

As Northern is a wholly-owned subsidiary of Parkway, which in turn is a wholly owned subsidiary of IHHL, IHHL, is under the SFA, deemed to be interested in the 225,747,944 Units in which Fortis is deemed to be interested in.
