The change in interest which is the subject of this notification is due to the exercise of 200,000 share options granted to Mr Tan Pheng Hock under the Singapore Technologies Engineering Share Option Plan ("ESOP").

As at 16 January 2014, the total number of shares underlying the options/awards held after the change is up to 2,692,212, which comprises the following:

(a) 1,200,000 share options granted pursuant to the ESOP;

(b) up to 1,147,500 shares are comprised in the conditional PSP Award of performance shares, subject to performance targets set over a three-year period, pursuant to the Singapore Technologies Engineering Performance Share Plan 2010. A minimum threshold performance is required for any performance share to be released and the actual number of performance shares to be released is capped at 170% of the conditional PSP Award;

(c) 24,096 shares are unvested restricted shares to be released according to the stipulated vesting periods pursuant to the Singapore Technologies Engineering Restricted Stock Plan;

(d) 47,616 Shares are unvested restricted shares to be released according to the stipulated vesting periods pursuant to the Singapore Technologies Engineering Restricted Share Plan 2010 ("RSP 2010"); and

(e) up to 273,000 shares are comprised in a conditional RSP Award of restricted shares, subject to performance targets set over a two-year period, pursuant to the RSP 2010. A minimum threshold performance is required for any restricted share to be released. A specified number of restricted shares to be released will depend on the extent of achievement of all performance conditions and will be delivered in phases according to the stipulated vesting periods.

The percentage interests shown in Item 8 above are calculated based on 3,106,763,805 issued shares in the capital of Singapore Technologies Engineering Ltd as at 16 January 2014.
