Yi Investment Pte. Ltd., which holds 90,581,300 Shares in the Company directly, is jointly owned by Phua Lam Soon and Ong Siew Eng. Accordingly, Phua Lam Soon is also deemed to be interested in the 54,348,780 Rights Shares provisionally allotted to the name of Yi Investment Pte. Ltd. pursuant to the Rights Issue.
