The change in deemed interest arose because Ms Yuen Thio's husband was issued ESR-REIT units through his CPF Investment Account pursuant to the Distribution Reinvestment Plan (DRP) in Sep 2020, Dec 2020 and Mar 2021. He was not aware that the CPF Agent Bank had standing instructions, given many years ago. As no notification was given of each DRP exercise, Mr Thio was not aware that his instructions to take cash only had not been communicated to the Agent Bank or that he had been issued DRP units, until recently.
