Leading Wealth Global Inc holds 646,952,678 ESR-REIT units and is a wholly-owned subsidiary of Longemont Real Estate Pte Ltd, which is in turn a wholly-owned subsidiary of Shanghai Summit (Group) Co., Ltd.

Both SSPL and Shanghai Summit (Group) Co., Ltd are wholly owned by Tong Jinqun. Therefore, Tong Jinqun is deemed to be interested in the 754,346,029 ESR-REIT units held by the above-mentioned entities.
