None of the Directors or substantial shareholders of the Company has any interest, direct or indirect, in the strategic joint sales agreement other than through their shareholdings (if any) in the Company.

HDSI will provide SD with technical training and sales support to ensure high-value customer engagement, while SD will provide customers with its complementary systems engineering capabilities and contribute pan-Asia sales reach to the partnership.

Mr. Akira Maruyama, President & CEO of HDSI commented: “Forming a new partnership with Servo Dynamics — a company with a strong presence across the Asian market — marks a significant strategic step forward for HDSI as we pursue our vision of becoming the best provider of total motion control solutions in harmony with

the future. This collaboration will serve as a vital foothold for our growth across Asia, a region full of dynamic opportunities.”
