Notice of Annual General Meeting

NOTICE IS HEREBY GIVEN THAT the Annual General Meeting (“AGM”) of the Company will be held at Heliconia Junior Ballroom, Level 3 (Room 3411 & 3511), Sands Expo & Convention Centre, 10 Bayfront Ave, Singapore 018956 (the “Physical Meeting”) and by way of electronic means (the “Virtual Meeting”) on Friday, 26 April 2024 at 2.00 p.m., for the purpose of transacting the following businesses:

As Ordinary Business

1. To receive and adopt the Audited Financial Statements of the Company for the financial year ended 31 December 2023 together with the Directors’ Statements and the Auditors’ Report thereon. **(Resolution 1)**
2. To re-elect Mr Lim Wee Kian who is retiring by rotation pursuant to Regulation 89 of the Constitution of the Company, and who, being eligible, offer himself for re-election. *(See Explanatory Note 1)* **(Resolution 2)**
3. To re-elect Mr Mark Rudolph Duncan who is retiring by rotation pursuant to Regulation 89 of the Constitution of the Company, and who, being eligible, offer himself for re-election. *(See Explanatory Note 2)* **(Resolution 3)**
4. To re-elect Mr Wong Tin Niam Jean Paul who is retiring pursuant to Regulation 89 of the Constitution of the Company, and who, being eligible, offer himself for re-election. *(See Explanatory Note 3)* **(Resolution 4)**
5. To approve a tax exempt (one-tier) final dividend of 1.4 cents per ordinary share for the financial year ended 31 December 2023. **(Resolution 5)**
6. To approve the payment of Directors’ fees of \$911,150 to the Non-Executive Directors (including Independent Directors) for the financial year ending 31 December 2024. \$698,000 will be paid in cash on a quarterly basis and \$213,150 will be paid by issuance of equivalent shares to the Non-Executive Directors (including Independent Directors) with the number of shares rounded up to the nearest hundred. *(See Explanatory Note 4)* **(Resolution 6)**
7. To re-appoint Messrs KPMG LLP as Auditors of the Company and to authorise the Directors to fix their remuneration. **(Resolution 7)**
8. To transact any other ordinary business which may be properly transacted at an AGM.

As Special Business

To consider and, if thought fit, to pass the following resolutions as Ordinary Resolutions, with or without any modifications:

9. Authority to issue shares **(Resolution 8)**

“That, pursuant to Section 161 of the Companies Act 1967 (the “Companies Act”) and Rule 806(2) of the Listing Manual of the Singapore Exchange Securities Trading Limited (the “SGX-ST”), authority be and is hereby given to the Directors of the Company to:-

 - (a) (i) issue shares in the capital of the Company (“Shares”) whether by way of rights, bonus or otherwise; and/or
 - (ii) make or grant offers, agreements or options (collectively, “Instruments”) that might or would require shares to be issued, including but not limited to the creation and issue of (as well as adjustments to) warrants, debentures or other instruments convertible into shares,

at any time and upon such terms and conditions and for such purposes and to such persons as the Directors may in their absolute discretion deem fit; and

(b) (notwithstanding the authority conferred by this Resolution may have ceased to be in force) issue shares in pursuance of any Instrument made or granted by the Directors while this Resolution was in force, provided that:

(1) the aggregate number of shares to be issued pursuant to this Resolution (including shares to be issued in pursuance of Instruments made or granted pursuant to this Resolution) does not exceed fifty per cent. (50%) of the Company's total number of issued shares excluding treasury shares and subsidiary holdings (as calculated in accordance with sub-paragraph (2) below), of which the aggregate number of shares to be issued other than on a *pro-rata* basis to existing shareholders of the Company (including shares to be issued in pursuance of Instruments made or granted pursuant to this Resolution) does not exceed twenty per cent. (20%) of the Company's total number of issued shares excluding treasury shares and subsidiary holdings (as calculated in accordance with sub-paragraph (2) below);

(2) (subject to such manner of calculation as may be prescribed by the SGX-ST) for the purpose of determining the aggregate number of shares that may be issued under sub-paragraph (1) above, the total number of issued shares (excluding treasury shares and subsidiary holdings) is based on the Company's total number of issued shares (excluding treasury shares and subsidiary holdings) at the time this Resolution is passed, after adjusting for:

(i) new shares arising from the conversion or exercise of any convertible securities or share options or vesting of share awards which are outstanding or subsisting at the time this Resolution is passed; and

(ii) any subsequent bonus issue, consolidation or subdivision of shares;

Adjustments in accordance with (i) and (ii) above are only to be made in respect of new shares arising from convertible securities, share options or share awards which were issued and outstanding or subsisting at the time of the passing of this Resolution;

(3) in exercising the authority conferred by this Resolution, the Company shall comply with the provisions of the Listing Manual of the SGX-ST for the time being in force (unless such compliance has been waived by the SGX-ST) and the Constitution for the time being of the Company; and

(4) (unless revoked or varied by the Company in general meeting) the authority conferred by this Resolution shall continue in force until the conclusion of the next AGM of the Company or the date by which the next AGM of the Company is required by law to be held, whichever is the earlier." 10. Proposed renewal of the Share Buy Back Mandate

(Resolution 9)

"That:

(a) for the purposes of Section 76C and 76E of the Companies Act, the exercise by the Directors of the Company of all the powers of the Company to purchase or otherwise acquire Shares not exceeding in aggregate the Maximum Percentage (as hereafter defined), at such price or prices as may be determined by the Directors from time to time up to the Maximum Price (as hereafter defined), whether by way of:

- (i) on-market purchase(s) on the SGX-ST; and/or
- (ii) off-market purchase(s) is effected otherwise than on the SGX-ST in accordance with any equal access scheme(s) as may be determined or formulated by the Directors of the Company as they consider fit, which scheme(s) shall satisfy all the conditions prescribed by the Companies Act;

And otherwise in accordance with all other laws and regulations and rules of the SGX-ST as may for the time being be applicable, be and is hereby authorised and approved generally and unconditionally (the "Share Buy Back Mandate");

- (b) unless varied or revoked by the Company in general meeting, the authority conferred on the Directors of the Company pursuant to the Share Buy Back Mandate may be exercised by the Directors at any time and from time to time during the period commencing from the date of the passing of this Resolution and expiring on the earliest of:

- (i) the date on which the next AGM of the Company is held or required by law to be held;
- (ii) the date on which the purchases or acquisitions of Shares by the Company pursuant to the Share Buy Back Mandate are carried out to the full extent mandated;
- (iii) the date on which the authority conferred by the Share Buy Back Mandate is varied or revoked by Shareholders in general meeting;

- (c) in this Resolution:

"Maximum Percentage" means the number of issued Shares representing 10% of the total number of issued Shares as at the date of the passing of this Resolution (excluding any Shares which are held as treasury shares as at that date);

"Maximum Price" in relation to a Share to be purchased or acquired, means the purchase price (excluding brokerage, commission, applicable goods and services tax and other related expenses) which shall not exceed:

- (i) in the case of a market purchase of a Share, 105% of the Average Closing Price of the Shares; and
- (ii) in the case of an off-market purchase of a Share, 110% of the Average Closing Price of the Shares;

"Average Closing Price" means the average of the closing market prices of a Share over the last five (5) Market Days on which the Shares are transacted on the SGX-ST or, as the case may be, such securities exchange on which the Shares are listed or quoted, immediately preceding the date of the market purchase by the Company or, as the case may be, the date of the making of the offer pursuant to the off-market purchase, and deemed to be adjusted, in accordance with the rules of the SGX-ST, for any corporate action that occurs after the relevant five-day period; and

"Date of the making of the offer" means the date on which the Company makes an offer for the purchase or acquisition of Shares from holder of Shares, stating therein the relevant terms of the equal access scheme for effecting the off-market purchase;

- (d) the Directors of the Company and/or any of them be and are hereby authorised to complete and do all such acts and things (including executing such documents as may be required) as they and/or he may consider expedient or necessary to give effect to the transactions contemplated and/or authorised by this Resolution." 11. The Proposed Adoption and Implementation of the 2024 iFAST Performance Share Plan

(Resolution 10)

"That:

- (a) the performance share plan to be known as the "2024 iFAST Performance Share Plan" (the "**2024 iFAST PSP**"), the rules of which (the "**2024 iFAST PSP Rules**") have been appended to and a summary of which is set out in Appendix B to this Notice and under which awards (the "**Awards**") of fully paid-up Shares will be granted, free of charge to such eligible persons on such terms and conditions and in accordance with the 2024 iFAST PSP Rules, be and is hereby approved and adopted;
- (b) the Directors and/or the remuneration committee of the Company (the "**Committee**") to administer the 2024 iFAST PSP, be and are hereby authorised as follows:
 - (i) to establish and administer the 2024 iFAST PSP;
 - (ii) to modify and/or amend the 2024 iFAST PSP from time to time, provided that such modifications and/or amendments are effected in accordance with the 2024 iFAST PSP Rules and to do all such acts and to enter into all such transactions, arrangements and agreements as may be necessary or expedient in order to give full effect to the 2024 iFAST PSP;
 - (iii) in accordance with Section 161 of the Companies Act, to grant Awards in accordance with the 2024 iFAST PSP Rules and to allot and issue or deliver, from time to time, such number of new Shares required pursuant to the vesting of the Awards under the 2024 iFAST PSP (provided that the aggregate number of Shares over which options or awards are granted under the 2024 iFAST PSP, the 2024 iFAST ESOS (as defined below) and any other share-based incentive schemes or share plans of the Company, shall not exceed 15.0% of the total number of issued Shares (excluding any treasury shares and subsidiary holdings that may be held by the Company from time to time));
 - (iv) subject to the same being allowed by law, to apply any Share purchased or acquired under any share purchase mandate and to deliver such existing Shares towards the satisfaction of the Awards granted under the 2024 iFAST PSP; and
 - (v) to complete and do all acts and things (including executing such documents as may be required) as they may consider necessary, desirable or expedient to give effect to or for the purposes of this Resolution or as they shall deem fit in the interests of the Company."

12. The Proposed Adoption and Implementation of the 2024 iFAST Employee Share Option Scheme

(Resolution 11)

"That:

- (a) the performance share plan to be known as the "2024 iFAST Employee Share Option Scheme" (the "**2024 iFAST ESOS**"), the rules of which (the "**2024 iFAST ESOS Rules**") have been appended to and a summary of which is set out in Appendix B to this Notice and under which options of the Company (the "**Options**") will be granted to such eligible persons to subscribe for Shares in the Company on such terms and conditions and in accordance with the 2024 iFAST ESOS Rules, be and is hereby approved and adopted;

(b) the Directors and/or the Committee to administer the 2024 iFAST ESOS, be and are hereby authorised as follows:

- (i) to establish and administer the 2024 iFAST ESOS;
- (ii) to modify and/or amend the 2024 iFAST ESOS from time to time, provided that such modifications and/or amendments are effected in accordance with the 2024 iFAST ESOS Rules and to do all such acts and to enter into all such transactions, arrangements and agreements as may be necessary or expedient in order to give full effect to the 2024 iFAST ESOS;
- (iii) in accordance with Section 161 of the Companies Act, to grant Options in accordance with the 2024 iFAST ESOS Rules and to allot and issue or deliver, from time to time, such number of new Shares required pursuant to the exercise of the Options under the 2024 iFAST ESOS (provided that the aggregate number of Shares over which options or awards are granted under the 2024 iFAST ESOS, the 2024 iFAST PSP and any other share-based incentive schemes or share plans of the Company, shall not exceed 15.0% of the total number of issued Shares (excluding any treasury shares and subsidiary holdings that may be held by the Company from time to time));
- (iv) subject to the same being allowed by law, to apply any Share purchased or acquired under any share purchase mandate and to deliver such existing Shares towards the satisfaction of the Options granted under the 2024 iFAST ESOS; and
- (v) to complete and do all acts and things (including executing such documents as may be required) as they may consider necessary, desirable or expedient to give effect to or for the purposes of this Resolution or as they shall deem fit in the interests of the Company."

13. The Proposed Grant of Authority to Offer and Grant Options under the 2024 iFAST Employee Share Option Scheme at a Discount

(Resolution 12)

"That, subject to and contingent upon Ordinary Resolution 11 as set out in this Notice being approved:

- (a) approval be and is hereby given for Options to be granted under the 2024 iFAST ESOS with exercise prices set at a discount not exceeding 10.0% of the Market Price (as defined below) for the Shares at the time of the grant of the Option, provided that such discount does not exceed the relevant limits set by the SGX-ST from time to time; and
- (b) in this Notice, the term (i) "**Market Price**" means the average of the last dealt prices for a Share determined by reference to the daily Official List published by the SGX-ST for a period of five (5) consecutive Market Days immediately prior to the relevant Offer Date provided always that in the case of a Market Day on which the Shares are not traded on the SGX-ST, the last dealt price for Shares on such Market Day shall be deemed to be the last dealt price of the Shares on the immediately preceding Market Day on which the Shares were traded, rounded up to the nearest whole cent in the event of fractional prices; and (ii) "**Market Day**" means a day on which the SGX-ST is open for trading in securities."

14. The Proposed Participation of Mr Lim Chung Chun, a Controlling Shareholder of the Company, in the 2024 iFAST Performance Share Plan **(Resolution 13)**

“That, subject to and contingent upon Ordinary Resolution 10 as set out in this Notice being approved, the participation by Mr Lim Chung Chun, a Controlling Shareholder of the Company, in the 2024 iFAST PSP, be and is hereby approved.”

15. The Proposed Participation of Mr Lim Chung Chun, a Controlling Shareholder of the Company, in the 2024 iFAST Employee Share Option Scheme **(Resolution 14)**

“That, subject to and contingent upon Ordinary Resolution 11 as set out in this Notice being approved, the participation by Mr Lim Chung Chun, a Controlling Shareholder of the Company, in the 2024 iFAST ESOS, be and is hereby approved.”

16. The Proposed Grant of Options under the 2024 iFAST Employee Share Option Scheme to Mr Lim Chung Chun, a Controlling Shareholder of the Company **(Resolution 15)**

“That, subject to and contingent upon Ordinary Resolutions 11 and 14 as set out in this Notice being approved, the proposed grant of Options under the 2024 iFAST ESOS to Mr Lim Chung Chun, a Controlling Shareholder of the Company, pursuant to and in accordance with the 2024 iFAST ESOS Rules, on the following terms be and is hereby approved, and the Directors be and are hereby authorised to allot and issue or deliver from time to time such number of Shares upon the exercise of such Options:

As background, pursuant to the terms of the Service Agreement dated 1 January 2021, Mr Lim Chung Chun is entitled to a long-term incentive of share options to the fair value of S\$250,000 to be vested in accordance with the staff performance shares/options vesting period. The number of share options to be granted to him will be capped at 0.5% of the number of issued Shares (excluding treasury shares and subsidiary holdings) of the Company at the date of grant.

(a)	Proposed date of grant of Options	:	1 July 2024
(b)	Number of Shares comprised in Options	:	Actual number of Options to be awarded will be determined by reference to the Market Price, and in any case, (a) the aggregate number of shares available to Controlling Shareholders and their associates shall not exceed 25.0% of the shares available under the 2024 iFAST ESOS; and (b) the number of shares available to Mr Lim Chung Chun or his associate shall not exceed 10.0% of the shares available under the 2024 iFAST ESOS. The Company will ensure compliance with Rule 845 of the Listing Manual of the SGX-ST.
(c)	Exercise price per Option	:	The exercise price will be set at 5.0% higher than Market Price before the date of grant of options.
(d)	Exercise period of Options	:	Exercisable at any time after one (1) year from the date of grant, pursuant to 2024 iFAST ESOS Rule 11, and subject to 2024 iFAST ESOS Rule 13. For the avoidance of doubt, the Company adopts a stricter policy, whereby approximately one-third of the options will be exercised after two (2) years from the date of grant and the remaining of approximately two-third of the options will be exercised after three (3) years from the date of grant.
(e)	Validity period of Options	:	10 years from the date of grant.

Assuming that the date of grant of options is the Latest Practicable Date, the estimated number of Options to be granted is measured based on the Binomial Model with the following assumptions:

- (i) the average closing price of Shares for five (5) consecutive Market Days immediately preceding the date of grant of Options is S\$7.10;
- (ii) the exercise price is S\$7.45;
- (iii) the validity period of the options is 10 years from the date of grant of such Options; and
- (iv) the expected volatility is based on the one (1) year historic volatility of the price of the Shares, adjusted for any expected changes to future volatility.

Solely for illustrative purposes, based on the fair value of share options calculated using the Binomial Model with the above assumptions, the estimated number of Options to be granted to Mr Lim Chung Chun is 97,200.

Shareholders are to note that the above is an estimation for the number of Options to be granted and is solely for illustrative purposes. The actual number of Options to be granted and the assumptions to be used for the calculation of the actual number of Options to be granted may change at the date of grant on 1 July 2024." Explanatory Notes on Businesses to be Transacted

1. Mr Lim Wee Kian, if re-elected, will remain as a member of the Board Risk Committee. Detailed information of Mr Lim Wee Kian can be found under Additional Information on Directors Seeking Re-election of the Company's Annual Report.
2. Mr Mark Rudolph Duncan, if re-elected, will remain as Lead Independent Director, Chairman of Nominating Committee and Remuneration Committee and member of the Board Risk Committee. Mr Mark Rudolph Duncan will be considered independent for the purposes of Rule 704(8) of the Listing Manual of the Singapore Exchange Securities Trading Limited. Detailed information of Mr Mark Rudolph Duncan can be found under Additional Information on Directors Seeking Re-election of the Company's Annual Report.
3. Detailed information of Mr Wong Tin Niam Jean Paul can be found under Additional Information on Directors Seeking Re-election of the Company's Annual Report.
4. Subject to the approval of Ordinary Resolution No. 6, the share awards will be granted to all Non-Executive Directors on 1 July 2024 as part of their Directors' fees subject to vesting conditions of approximately one-third of the share awards will be vested after 2 years from date of grant and the remaining approximately two-third of the share awards will be vested after 3 years from date of grant. The actual number of shares to be awarded will be determined by reference to the average closing price of shares for 5 consecutive market days immediately prior to the date of award.
5. The Ordinary Resolution No. 8 proposed in Item 9 above, if passed, will empower the Directors from the date of the above Meeting until the date of the next AGM, to allot and issue shares and convertible securities in the Company. The aggregate number of shares (including any shares issued pursuant to the convertible securities) which the Directors may allot and issue under this Resolution will not exceed fifty per cent. (50%) of the Company's total number of issued shares excluding treasury shares and subsidiary holdings of the Company. For issues of shares other than on a *pro rata* basis to all shareholders, the aggregate number of shares to be issued will not exceed twenty per cent. (20%) of Company's total number of issued shares excluding treasury shares and subsidiary holdings of the Company. This authority will, unless previously revoked or varied at a general meeting, expire at the next AGM of the Company or the date by which the next AGM of the Company is required by law to be held, whichever is earlier. However, notwithstanding the cessation of this authority, the Directors are empowered to issue shares pursuant to any Instrument made or granted under this authority.
6. The Ordinary Resolution No. 9 proposed in Item 10 is to give the Company the flexibility to undertake buy backs of the Shares at any time, subject to market conditions, during the period when the Share Buy Back Mandate is in force, subject to the conditions set out in the Ordinary Resolution No. 9.

The Company intends to use internal resources or external borrowings or a combination of both to finance the purchase or acquisition of its Shares. The amount of financing required for the Company to purchase or acquire its Shares, and the impact on the Company's financial position cannot be ascertained as at the date of this Notice as these will depend on the number of Shares purchased or acquired, whether the purchase or acquisition is made out of capital or profits, the price at which such Shares were purchased or acquired and whether the Shares purchased or acquired are held in treasury or cancelled.

Based on the issued share capital of the Company comprised 297,846,091 Shares of which 12,890 Shares that are held in treasury as at 7 March 2024 ("Latest Practicable Date"), and assuming that no further Shares are issued on or prior to the AGM, not more than 29,783,320 Shares (representing 10% of the Shares in issue as at that date (excluding treasury shares and subsidiary holdings)) may be purchased or acquired by the Company pursuant to the proposed Share Buy Back Mandate. However, pursuant to Section 76I(1) of the Companies Act, the Company can only hold 10% of its Shares (being 29,784,609 Shares) in treasury. Therefore, even though the Share Buy Back Mandate provides for potentially up to 29,783,320 Shares to be purchased or acquired by the Company, the maximum number of Shares that the Company can purchase or acquire and hold in treasury is 29,771,719 Shares.

In the case of Market Purchases by the Company and assuming that the Company purchases or acquires 29,771,719 Shares at the Maximum Price of \$7.45 for each Share (being the price equivalent to 105% of the Average Closing Price of the Shares for the five (5) consecutive Market Days on which the Shares were traded on the SGX-Mainboard immediately preceding the Latest Practicable Date), the maximum amount of funds required for the purchase or acquisition of 29,771,719 Shares is approximately \$221.8 million.

In the case of Off-Market Purchases by the Company and assuming that the Company purchases or acquires 29,771,719 Shares at the Maximum Price of \$7.81 for each Share (being the price equivalent to 110% of the Average Closing Price of the Shares for the five (5) consecutive Market Days on which the Shares were traded on the Official List of the SGX-ST immediately preceding the Latest Practicable Date), the maximum amount of funds required for the purchase or acquisition of 29,771,719 Shares is approximately \$232.5 million.

The financial effects of the purchase or acquisition of the Shares by the Company pursuant to the proposed renewal of the Share Buy Back Mandate on the audited financial statements for the financial year ended 31 December 2023 based on these assumptions are set out in paragraph 2.7 of the Appendix A to Shareholders dated 4 April 2024 issued together with the Company's Annual Report.

A Share Buy Back at the appropriate price level is one of the ways through which the return on equity of the Group may be enhanced. Further, amongst others, a Share Buy Back provides the Company with a mechanism to facilitate the return of surplus cash over and above its ordinary capital requirements in an expedient and cost-efficient manner. The Directors also expect that Share Buy Backs may also help mitigate against short-term volatility of share price, offset the effects of short-term speculation and bolster Shareholders' confidence. Share Buy Backs will also allow the Directors greater control over the Company's share capital structure, dividend payout and cash reserves.

The buy back of Shares may, depending on market conditions and funding arrangements at the time, lead to an enhancement of the EPS and/or NAV per Share of the Company and the Group, and will only be made when the Directors believe that such buy back would benefit the Company and its Shareholders.

Shareholders should note that purchases or acquisitions of Shares pursuant to the Share Buy Back Mandate via market purchases or off-market purchases will only be made when the Directors believe that such purchases or acquisitions would be made in circumstances which would not have a material adverse effect on the financial position of the Company. Please refer to the Appendix A to Shareholders dated 4 April 2024 issued together with the Company's Annual Report for details.

For the foregoing reasons, the Directors seek to renew the Share Buy Back Mandate, which was approved by Shareholders at the Extraordinary General Meeting held on 21 October 2014 and last renewed at the AGM held on 26 April 2023.

7. The Ordinary Resolution No. 15 proposed in Item 16 above, if passed, will empower the Directors to grant options equivalent to \$250,000 to Mr Lim Chung Chun based on the terms set out in Item 16 which is in accordance with the terms of the Service Agreement dated 1 January 2021.

Pursuant to the terms of the Service Agreement dated 1 January 2021, Mr Lim Chung Chun is entitled to a long-term Incentive of share options to the fair value of \$250,000 to be vested in accordance with the staff performance shares/options vesting period.

The number of share options to be granted to him will be capped at 0.5% of the number of issued Shares (excluding treasury shares and subsidiary holdings) of the Company at the date of grant.

Specific approval is being sought for Mr Lim Chung Chun's participation in the iFAST ESOS under Ordinary Resolution No. 14 proposed in Item 15 above. A separate resolution must be passed by ordinary resolution to approve the actual number and terms of options to be granted to Mr Lim Chung Chun, who is the Executive Chairman and CEO and also a Controlling Shareholder of the Company. If Ordinary Resolution No. 15 is not approved, \$250,000 will be awarded in cash pursuant to the terms of the Service Agreement dated 1 January 2021.

The estimation for the number of options to be granted in Ordinary Resolution No. 15 proposed in Item 16 above is solely for illustrative purposes. The actual number of options to be granted and the assumptions to be used for the calculation of the actual number of options to be granted may change at the date of grant on 1 July 2024.
